Terms and Conditions

• Initial Deposit & Payments

Buyer is responsible to place a deposit of \$ _____, with the payment of balance of \$ _____ due upon release of the Dog to the buyer.

Expected Delivery Date: _____, 20 _____, OR such other date as the parties may mutually agree.

Buyer acknowledges and agrees that BUYER will forfeit the deposit and any rights to the Dog if:

- (a) Buyer fails to complete the purchase of the Dog for any reason, and / or
- (b) Buyer fails to pay the balance of the Purchase Price within **10 days** of the agreed delivery date.

In either events, Seller shall be free to sell the DOG to another party.

In the event that the Dog is not available due to sickness, death, or any other circumstances owing to the fault of Seller, Buyer's deposit will be transferred to the next litter of dog. To ensure the health of each dog, Seller may request to postpone the delivery date of the Dog. This is to ensure that the Dog is fully weaned and ready to go to his/her forever home. However, this request does not provide the warrant for any buyers to cancel and/or receive the any refunds of the payment.

If necessary, the Dog may be returned to Seller for a replacement dog within **FOURTY EIGHT** hours from the time of delivery. Please be informed that we do NOT provide any cash refund. In the event of such occurrence, **NO TREATMENT** by buyer is authorized. If any treatment is provided, this guarantee is not valid to all buyers.

• Transfer of Ownership and AKC Registration

Upon payment in full of the purchase, Buyer would have the rightful ownership of the Dog. The Dog is registrable to AKC upon the Buyer's request. There will be **additional \$200 fee** to acquire the AKC Registration Form from Seller.

• **Seller / Buyer Representations and Warranties**

Seller represents and warrants to BUYER that:

- (1) Seller is the legal and true owner of the Dog, and the Seller has the full right and authority to sell and transfer the ownership of the Dog to the Buyer upon the completion of payments.
- (2) Seller guarantees that the Dog is a purebred dog, offspring of the purebred sire and purebred dam.
- (3) Seller does not guarantee the size, color, hair texture and/or length, temperament, breeding ability and/or house training ability of the Dog.

The Dog is in good health at the time of this sale. Seller provides the documents listed below to inform Buyer the health condition of the Dog upon the delivery.

*Buyer is responsible to take the Dog to the licensed veterinarian to be examined within 48 hours after the delivery of the Dog, at the Buyer's cost.

*If the Dog fails the examination, Buyer may return the Dog, with the written statement from the veterinarian for a replacement dog (not to exceed the value of previous one).

* Seller will NOT provide a replacement dog if the condition of the Dog is non-life threatening such as Coccidiosis, Giardia, Hypoglycemia, Kennel Cough, Pneumonia, Ear Mites, Ear Infections, Skin Mites, Mange, Cherry Eye, or other non-life threatening conditions on eye, skin, or for undescended testicles. It also includes a non-life threatening open fontanel, Over or Under Bites, Herniations (Inguinal, Perineal, or Diaphragmatic), non-life-threatening bone or joint disorders such as but not limited to luxating patellas, and Heart Murmurs that are not-life threatening.


* Seller agrees to notify Buyer if the veterinarian discovers any of the conditions listed above during the medical examination prior to the delivery of the Dog.

*Failure by Buyer to have the Dog examined within 48 hours will nullify this warrant of providing a replacement dog.

All veterinarian charges incurred by the buyer are sole responsibility of the buyer and will under NO circumstances be paid by Seller.

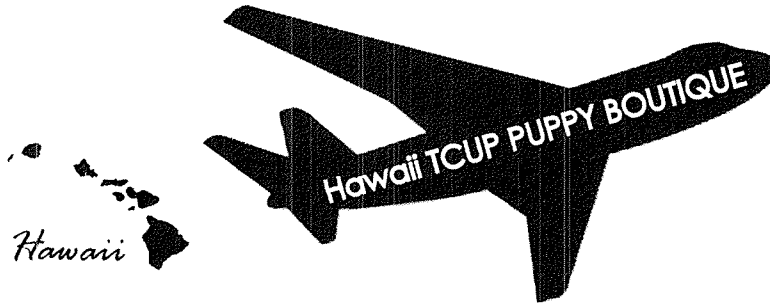

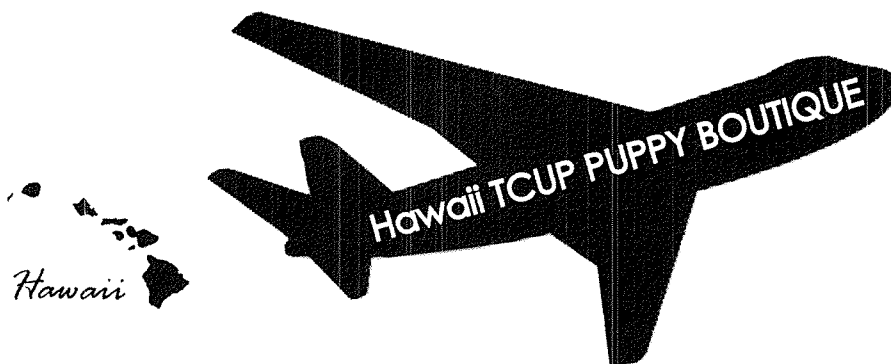
Optional Blood Test(s) \$ _____
